## TERMS AND CONDITIONS

1. That all accounts are due and payable net thirty (30) days from the date of billing. All accounts in excess of thirty (30) days from the date of the first billing shall be considered a past due account and said account shall bear interest which shall be added to the account on the next monthly statement computed by periodic rate of one and one-half percent (1 ½%) on the previous balance, which corresponds to an annual percentage rate of eighteen (18%). Payments and/or credits received after thirty (30) days of billing date will not be deducted from the previous balance for computation of the finance charge.

In addition to the above-stated balance and finance charge, Purchaser shall be responsible on any past due account for attorney fees, court costs and interest, if any action is brought to collect on said account, all without relief from valuation and appraisal laws.

2. Any shortages or errors on orders delivered or picked up must be reported to Crown Brick within twenty-four (24) hours from pick up or delivery time.
3. When Crown Brick delivers materials and/or supplies to the site as requested by the Purchaser, the Purchaser hereby authorizes Crown Brick to leave said materials and/or supplies at the said site.
4. These terms and conditions shall supersede any provisions, terms and conditions contained on any confirmation order, or other writing the Contractor may give to or receive from any party with respect to the Material. The rights of the parties hereto shall be governed exclusively by the provisions, terms and conditions hereof. Crown Brick makes no representations or warranties concerning this agreement except as are expressly contained hereof, and this agreement may not be changed or modified orally.
5. Crown Brick & Supply, Inc. shall provide waivers of lien for amounts paid only upon receipt of such payment.
6. Any purchase order given under this agreement shall be deemed a separate contract and notwithstanding the fact that such purchase order incorporates by reference the terms of this agreement, each such purchase order shall be a new contract stated the date of such purchase order.
7. Prices quoted by Crown Brick & Supply, Inc. for materials shall only be for the price of the date of delivery thereof. Price quotes shall be in effect for thirty (30) days (*unless otherwise specified*) from the day of quotation and may be subject to change thereafter.
